Call to order: 7:30a.m.

Roll Call: All present except Sean Malone who is on vacation.

Pres. Lamp asked if all visitors had signed in. Pres. Lamp asked for comments from visitors.

Kim Westhoven inquired about the goat issue she brought forward at several past meetings.

Chuck Miller responded and so did Phil miller. This situation will Remain The same for now. Doug Leith asked about the previous discussion of having a meeting with the families involved in this goat Issue. This is not necessary for now.

Dave Bensen presented an update on the Log Cabin restoration. All the 2x4's have been removed from the outside sides of the cabin. We are now ready to proceed with getting bids.

Approximately 8 logs need to be replaced. These logs are White Oak.

One inspector said they still have 50% of life left in them. These logs are over 200 years old!

This restoration will not be cheap.

Working on donations. Here is a lot of interest in this project. Dave said that he talked with a gentleman about why we are so intent on saving the fairgrounds and the buildings. Dave presented this comment: You can visit where your great- great grandparents lived, If you need a doctor, we have a doctor in the doctors office on site, if you need gas, we have a gas station, we have a general store if you need groceries or materials for sewing clothes. We have a post office if you want to mail a post card. We have a church if you feel you need some "good old-time religion". We also have a school for the children to catch up on their homework. When you have finished your day and you are ready to go home, we will take you to our railroad station and send you on your way.

The funds for the Old Grandstand, could these funds or a portion of these funds be used toward the log cabin.

Could the Board pass a resolution that Dave Bensen and Webb Rice BB Project Coordinators for the log cabin restoration. Board Approved,

Cheryl asked about the 2 bids and the status of them. Dave said that the Donor was on board.

The estimate on this? Approximately \$50,000.00 is what will be asked for. Bensen said that we should know something within the next three weeks. Cheryl asked if the Jr. Fair Book was finished. IT is online.

Dustin Westhoven volunteered to be a weight Master

Poultry: discussions over being in the two buildings. Talked with Leslie about using the 4-H building. This is between Leslie, Scott and John. See Leslie's paper attached.
